## **Rules & Regulations** For the Discharge of Hauled Liquid Wastes

### **GENERAL RULES**

- GWA is a non-smoking facility. No smoking is permitted at any time.
- Permitted haulers may dump high strength waste at the designated receiving stations only.
- Permitted haulers can dump between the hours of 7am to 4pm Monday through Friday. There is no dumping allowed on federal holidays.
- Only drivers and trucks that were identified and approved for the permit will be allowed to discharge. New trucks and new drivers must be submitted for approval prior to arrival to dump.
- Haulers are expected to clean up any mess resulting from their discharge activities. Failure to do so will result in fines.
- Glenbard Wastewater Authority reserves the right to refuse a load for any reason at any time.
- Glenbard Wastewater Authority reserves the right to require that a load be discharged over a period
  of time so as not to negatively impact the plant.
- No hazardous waste or loads contaminated with hazardous waste may be discharged.
- Disposal fees are \$.05 per gallon and are based on the total volume of the truck.
- Unpaid monthly bills may result in not being allowed to dump.
- Insurance Certificates must be valid and on file at The Authority at all times.

## PROCEDURES FOR DISCHARGING A LOAD

- Haulers must stop at gate and push button to announce arrival and open the gate.
- The completed manifest must be given to an Authority employee for signature or left in the designated spot.

- Any garbage or rags left on the screen in the discharge box, must be removed and disposed of after each discharge.
- Hauler traffic is designed to go in a loop, please follow the designated route out the west gate after emptying the truck.

#### **SAMPLING**

The Authority intends to randomly analyze samples to determine the content of the load. This is done for two reasons, first to track the pollutant loading to the wastewater treatment plant, and second to assure that the load does not contain any unauthorized waste. The Authority reserves the right to increase or decrease, as it deems necessary, the number of pollutants to be monitored for in response to changes in waste quality, POTW parameter limits, flow, regulatory changes, or any other factor unknown at this time.

Should a sample test positive for unauthorized pollutants or contain levels of pollutants that exceed the typical characteristics of the authorized waste, the hauler may be responsible for the cost of the analysis, and subject to fines. In addition to fines, the Authority reserves the right to suspend or revoke discharge privileges.

#### **RECORD KEEPING**

All liquid waste being hauled to the Authority for disposal, shall be properly documented using an GWA manifest, an EPA Uniform Waste Manifest or a similar form approved by the Executive Director or his designate.

The hauler shall deliver a completed original manifest signed by the driver to the Authority prior to commencing discharge of the load.

The Authority, haulers, and generators of the wastes shall maintain records of all information or activities for a minimum of three years. This period of retention shall be extended during the course of any unresolved litigation regarding the discharge of pollutants by the hauler or noncompliance event or enforcement remedies initiated in accordance with any District Ordinance.

#### **FINE SCHEDULE**

| Failure to leave a properly filled out manifest                                   | \$50  |
|---|-------|
| Failure to leave the discharge area clean   | \$100 |
| Discharging load anywhere than the designated receiving station and a three month |       |
| suspension of disposal privileges.  | \$500 |

Repeat violations are subject to escalating fines at the discretion of the Authority. Repeat is defined as happen more than twice in a rolling 6 month timeframe.

Excessive violations may be cause for permit suspension or revocation.

The Authority shall in accordance with the Pretreatment Ordinance recover the costs for any investigations and additional compliance monitoring by charging the Permittee for sampling, analysis, and reporting fees for the samples collected pursuant to any noncompliance event or discharge permit compliance evaluation.

#### **ADDITONAL REGULATIONS**

Haulers must also comply with all Federal and State and local regulations they are subject to.
